

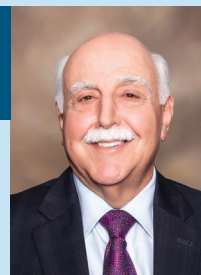


# By Endowing YOUR GIFT

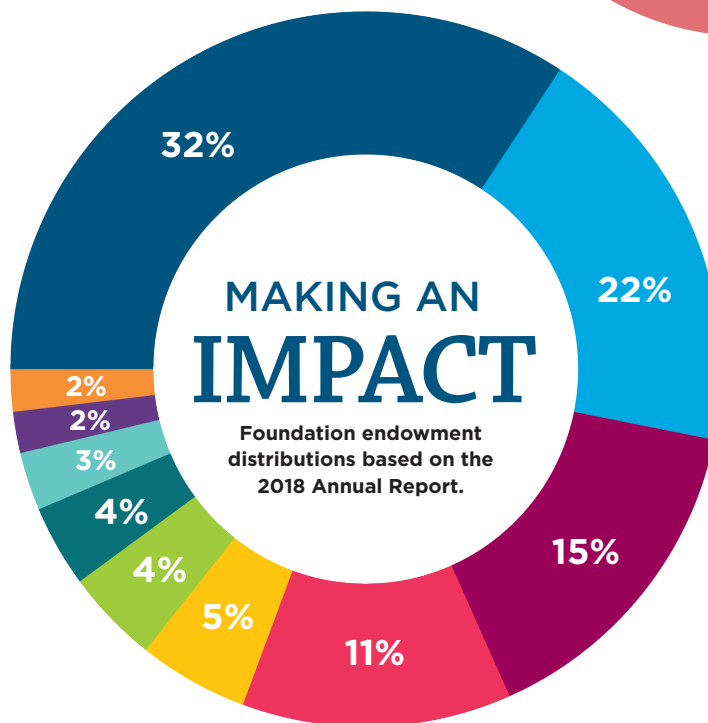

# HOW TO CREATE YOUR Jewish Legacy

## 4 Easy Steps

- 1 Sign a simple agreement
- 2 Decide on the name of your endowment and the purpose(s) you wish to support
- 3 Donate funds now or as a deferred gift, such as a bequest
- 4 Decide what to give - \$10,000 minimum - cash, securities, etc.
